Declaration & Undertaking

1. I will not indulge in any behaviour or act that constitutes ragging as defined under Clause 3 of the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.
2. I will not participate in, or propagate through any act, conduct that may be construed as ragging under the aforementioned Regulations.
3. I am aware that DIET, Lakhimpur is an environment-friendly institution that maintains its environment with sensitivity. I will not bring motor vehicles (four-wheelers) without prior permission from the authority.
4. I undertake that I will not litter or use kind of plastic within the DIET premises.
5. I undertake that will abide by the rule of the DIET of wearing helmets by both rider and pillion rider while commuting to the Institution.
6. I will participate in all curricular and co-curricular activities organised by the Institution as per the rules & regulations stated by the Govt. and affiliating bodies such as NCERT, NCTE, SCERT, Dibrugarh University.
7. I will abide by the rules and regulations of the Institution as laid down by the authority. I undertake that I shall neither indulge in, nor instigate or compel other students to indulge in, any activity that disturbs the healthy and peaceful atmosphere of the DIET premises or causes nuisance within the DIET. In case I am found involved in any act amounting to a violation of discipline or misconduct, the authority shall have the right to rusticate me or take any other appropriate disciplinary action against me.

9. I am aware that the entire Institution premises are under CCTV surveillance.

I will not use social media or any electronic platform against the authority of the Institution. If I am found to have used social or electronic media against the Institution's authority, the authority shall have the right to rusticate me from the course/Institution or to initiate any other action, including legal action, as deemed fit.

13. I will pay all necessary fees, including developmental fee, government fee, institutional fee, or any other fee notified by the Institution from time to time.
14. I shall not claim a refund of admission fees, institutional development fees, or other fees already paid, in the event of withdrawal from or discontinuation of the course.
15. In case of low attendance, as per the Institution's rules, the Institution shall have the right to take necessary action against me, such as declaring me Non-Collegiate, Dis-Collegiate, etc.
